In addition to supporting the Mississippi Blues Commission, the race's economic benefits to the Jackson area are significant. The Jackson Convention and Visitors Bureau estimates that the Blues Marathon contributed \$389,648 to the city of Jackson's economy in 2009, the most recent year for which data are

available. With many more participants this year, the race likely brought a much greater economic punch. Not only were JYL members able to help with the event, but it was a great way to celebrate the birthday of Mississippi native Elvis Presley and to celebrate the Mississippi Blues. 
Author Curtis Wilkie Discusses Book at JYL Luncheon

JYL was privileged to welcome Curtis Wilkie, author of *The Fall of the House of Zeus: The Rise and Ruin of America's Most Powerful Trial Lawyer*, as the guest speaker at the January 7, 2011 meeting at Hal & Mal's. Mr. Wilike, a Mississippi native, spoke in front of a packed room, providing insight into his most recent book about the history of politics in Mississippi, culminating in the Dick Scruggs bribery scandal.

Wilkie pointed out that Zeus provides information that the average follower of the scandal was not privy to as the events unfolded in 2008 and 2009. His book is the product of hours of interviews with the characters and, as he noted, is written more from Dick Scruggs's point of view than other authors' recounts of the events.

Wilkie described Zeus as a





political story about how politicians have been scratching each others' backs and "fixing" things in this state all of his life. The Scruggs story is one that is bigger and broader than one criminal case. Many of the main characters in Wilkie's book are personal friends of his and, as he admitted, some have become former friends since the book came out.

Wilkie attributes the great success of his book to four

things: his own honesty and attempt to eliminate any bias while telling the story, cooperation by the entire Scruggs family, cooperation of the prosecutors, and that virtually every character in the book agreed to speak with him.

If you were unable to attend the January JYL meeting, you still have an opportunity to hear Wilkie speak in Jackson. Along with Alan Lange and Tom Dawson, coauthors of *Kings of Tort*, he will be speaking on Tuesday, March 15th at Millsaps College about the status of traditional media and how new media, such as blogs, affect public perception.

Former JYL President Discusses Historic Judicial Elections

On November 12, 2010, JYL welcomed back former President Amanda Jones to share some Hal & Mal's catfish and red beans along with her unique perspective on the historic judicial elections held earlier in 2010.

Jones, a graduate of Mississippi State and Ole Miss Law, is currently Counsel to the Governor, having previously practiced law with Phelps Dunbar and Bradley Arant.

In her role as Counsel to the Governor, Jones became part of what may have been the first nonpartisan judicial write-in elections in Mississippi history, which took place in both the 13th Circuit election for Circuit Judge and the 10th Circuit election for Chancery Judge. The write-in

elections arose because two sitting judges, Judge Evans and Judge Thomas, who were the only candidates to qualify to run for their seats, passed away before election day. Because of slightly different factual circumstances, the ballot in the 13th Circuit contained only a blank under the Circuit Judge category, while the ballot in the 10th

Circuit listed Judge Thomas as the sole candidate. Under Mississippi election law, Jones reported, this led to two entirely different legal results, with a runoff election between write-in candidates emerging from the 13th Circuit election and deceased Judge Thomas's reelection in the 10th Circuit expected to result in an appointment by Governor Barbour there.

Jones certainly had to navigate some muddy legal research waters

in advising the governor about these unprecedented elections. JYL appreciates her willingness to share her experience with the membership.



Where Are They Now?

With Former JYL President Alex Alston

When Alex Alston gives directions to his home in Jackson's historic Belhaven, he tells his visitors to "look for the house with the really big magnolia tree out front." Big magnolia tree is right. Not only is the tree enormous, but according to Alston it serves as a tree-house for his grandkids and a launching pad for their make-believe ambushes on him. JYL recently interviewed Alston from his office at his home. Surrounded by well over a thousand books and a host of well-preserved Native American artifacts and relics, Alston is figuratively and literally at home in his exquisitely decorated office. Although retired from practicing law at a firm, Alston continues to devote his time to what he loves most – helping the less fortunate through the practice of law.

Alston, a trial lawyer and author, retired from Brunini, Grantham, Grower & Hewes having tried over 150 cases. He has argued cases before the Mississippi Supreme Court, the Fifth Circuit Court of Appeals, and the U.S. Supreme Court. He also served as the president of the Mississippi Bar and Jackson Young Lawyers, and he won the ABA John Minor Wisdom Award, an annual honor bestowed upon lawyers who provide legal service to the poor and under represented.

When asked by JYL about his philosophy towards the practice of law, Alston emphatically acknowledged that young lawyers should "work like hell, build a good reputation, and take responsibility for matters." In terms of responsibility, Alston believes that young lawyers should "step up to the plate and show their partners that they can do the work." He opined that "lawyering is the greatest profession on earth." "You are the only ones who hold the key to the courthouse door," he says. According to Alston, "every major change in this country's history can be attributed to the efforts of lawyers."

One of the themes Alston extolled during his interview is the need for civility throughout the practice. "Civility," he says, "is the oil that lubricates that cumbersome machinery of justice." No stranger to civility himself, Alston recalled that during his JYL presidency

he lead an effort that successfully desegregated the organization.

With regard to managing stress, Alston advises that "pressure is not necessarily a bad thing." "If you're not stressed out a bit," he says, "then you're doing something wrong." He hastens young lawyers to use stress to empower themselves to move forward. Alston also paused with great deliberation to offer the following jewel of advice: "It's okay to make mistakes. It's not the end of the world. People make mistakes. When standing it front of a jury, the jurors want to see that you are human. That you are credible."

In reviewing Alston's latest literary work - "A Devil's Sanctuary," a narrative account of the cruelties exhibited by the Mississippi legal system during the Civil Right's Movement – one becomes immediately aware that he is an individual who is still very much in love with the law. He is still a student of the law and continues to track the rulings of the Mississippi Supreme Court which is evidenced by his 2008 Op-Ed in the Clarion Ledger entitled "A Plea for Appellate Justice in Mississippi." Not only a student of the law but a student of the courtroom as well, he noted that his favorite thing about practicing is being in front of the jury. According to Alston, "juries are brilliant as a whole. They know everything about the case when it's over. They know everything from what color socks the advocates wore to the most mundane and trivial comment a witness may have made from the stand."

Alston is glad to see JYL continue its tradition of trumpeting pro bono efforts within the profession. When asked what his advice to the incoming or current JYL President is, Alston said, "he or she should stress professionalism, civility, and public service." Alston said "JYL's focus should be centered on doing whatever it can to help the needy and underprivileged."
