This month we would like to recognize JYL members Chanda Roby, Justin Peterson, and Jason Bush. Chanda and Justin received Outstanding Service Awards and Jason received the Outstanding Pro Bono Service Award at JYL's Evening Honoring the Judiciary on May 15, 2012. We thank them for their continued support of JYL through their involvement in committees and continued efforts to provide pro bono services to those less fortunate.

Chanda Roby:

Chanda is a graduate of the University of Mississippi School of Law and currently operates her own firm, The Law Office of Chanda L. Roby, PLLC, where she focuses her practice on alternative dispute resolution. She was recently awarded with JYL's Outstanding Service Award for 2011-2012 in recognition of her outstanding service as the Co-Chair of JYL's City Court Mediation Committee.



As co-chair of this committee, Chanda serves as a liaison be-

tween Jackson City Court and the committee, and assigns mediation cases to JYL members. She also handles all details and logistics for mediating cases at the court. In her first year as co-chair, Chanda and her committee devoted themselves to restructuring the process by which mediation cases were assigned, in an effort to ensure that more cases would be resolved on a yearly basis. The committee was assigned a total of twenty cases before this restructuring process began. Chanda hopes that their hard work will result in the assignment of more cases in 2013.

In addition to her mediation responsibilities, Chanda also organizes a yearly service project for the committee. This past year, the committee celebrated and supported the American Bar Association Dispute Resolution Section's National Mediation Week theme of Civil Public Discourse by encouraging JYL members and the Jackson City Council to adopt a resolution supporting the theme.

The ABA's theme of Civil Public Discourse focused on encouraging more respect and dignity among community leaders when addressing each other. This theme was chosen because ABA members were disappointed with the way public figures, especially those with legal backgrounds, publically disagree in a way that is unprofessional and disrespectful. Chanda agreed with the ABA, commenting: "there were many attorneys and other community leaders in Mississippi who felt the same way and thought JYL and the Jackson City Council were good places to start with support because so many people around Mississippi look to each as setting a standard to follow." The committee ultimately submitted a resolution recognizing the importance of civil public discourse which JYL and the Jackson City Council adopted.

Justin Peterson:

Justin is a graduate of The University of Virginia School of Law and currently practices real estate and corporate law for The State Street Group in Jackson. This year Justin was recognized for his outstanding service to JYL as the Co-Chair of the Athletic Committee and organizer of the first ever JYL bowling tournament in 2011.



The inaugural Barristers' Bowl was a team bowling competition and silent auction to benefit the Boys and Girls Club of Central Mississippi. Jason was quick to give thanks to his "fantastic and hard-working committee: Alex Martin and Lee Hill, who worked on sponsorships and team prizes; and Diandra Hosey and Kathryn White, who spearheaded the silent auction."

Justin and his committee raised approximately \$10,000 for the Boys and Girls Club. Justin wanted to give special thanks to: "the many law firms and business that donated to the silent auction; and the generous cooperation of Strike Entertainment, which provided us with their facilities for the event." Justin further noted, "it was great to see every lane filled with JYL bowlers!"

Jason Bush:

Jason is a graduate of the University of Mississippi School of Law and currently practices for Baker Donelson in Jackson. Jason currently focuses his practice on business litigation, intellectual property, and employment and construction litigation. Jason is being recognized by JYL for his continued support of

the community by providing his pro bono services to the less fortunate.

Most of Jason's pro bono cases have been divorce cases assigned through the Mississippi Volunteer Lawyer Project. These cases have allowed Jason to work with numerous special clients. One case Jason recalled involved a wife and mother of four children. According to Jason, "the father wasn't willing to concede much, so we had to ask some uncomfortable questions in Court to show why only supervised visitation was appropriate and in the best interests of the children. Once we met the



children, the case took on even more of a special purpose." Jason, with the assistance if Wesley Mockbee and Kenya Rachel, worked diligently to assist the client with resolving a situation that had caused her much stress and pain for no cost at all.

Jason has also provided pro bono services to a Christian music group by working with the Untied States Copyright Office and drafting a license agreement for the group. Jason provides these services because "it is the right things to do. Also, it can get you more court time and pro bono clients tend to be the most appreciative of what you have done for them."

ATHLETIC: The Athletic Committee coordinates the Legal Beagle 5K Race in March and is exploring the possibility of hosting a bowling tournament in the fall. These events are JYL's primary charitable fundraisers. All proceeds from the events go to local charities.

<u>CITY COURT MEDIATION:</u> Members of the JYL City Court Mediation Committee attend and conduct mediations at the Jackson Municipal Courthouse on a rotating basis. All volunteers are welcome; no special training or certification is required. This committee provides practical alternative dispute resolution experience and civic lessons for lawyers who may not otherwise see much of Municipal Court.

<u>COMMUNITY SERVICE:</u> The Community Service Committee works to benefit those in need in our community. Volunteers spend time with such organizations as Stewpot (serving meals, volunteering at legal clinic, painting houses in Bratton St. project), Operation Shoestring, Gateway Rescue Mission (painting and working on facility improvements, sorting donated clothing), Gleaners (picking up, delivering, and sorting food), and others. The committee is encouraged to initiate as many service projects as time and volunteers will support. Thanks to motivated committee chairs and members, JYL service projects have made an impact on the organizations they support and have occasionally evolved into impromptu social events for the participants.

DIVERSITY: The diversity committee is charged with advancing the diversity goals of the Jackson Young Lawyers. JYL's principal diversity goal is to grow into an organization that is truly representative of the diversity of the law practice in the Jackson metropolitan area. To achieve this goal, the diversity committee is responsible for increasing the participation of minority, public service and plaintiff attorneys in JYL activities. JYL is and should remain a relevant organization for ALL young lawyers in Greater Jackson, and the Diversity Committee is focused on achieving that end. This is a committee in which creative thinkers and well-connected young lawyers can make a difference.

<u>MEMBERSHIP:</u> The membership committee is in charge of recruiting new members, mainly at the two bar admissions ceremonies in the Fall and Spring. The committee is also responsible for making sure the Bar has the appropriate flyer/brochure to send out with the packets and attending the ceremonies.

OUTREACH PROJECTS: The Outreach Projects Committee administers JYL's Community Outreach Grant and LSAT Scholarship Programs.

PRO BONO: The pro bono committee of JYL seeks to promote and encourage pro bono involvement among young lawyers. The committee provides members of JYL information regarding pro bono opportunities from organizations and agencies providing legal counsel and representation to the poor and underserved. The committee also seeks to educate JYL members about the personal and professional importance of providing legal representation to those otherwise unable to afford an attorney. The committee hopes to continue to work with the Mississippi Volunteer Lawyers Project and the Mississippi Center for Legal Services Corporation throughout the coming year to establish a legal clinic staffed by JYL members who provide legal assistance with guardianships, emancipations and/or birth certificate correction issues. This year's chair may decide to shift the committee's focus to providing a slate of JYL volunteers for the MVLP's Legal Lines project. Young lawyers with less control over their own schedules often find it easier to do pro bono work in predictable blocks of time and the Legal Lines project is a good way to do that.

SOCIAL: The Social Committee plans and organizes JYL's social events throughout the year.

SPEAKERS/CLE: The Speakers/CLE Committee recruits the speakers for our membership meetings and annual CLE meeting.
