## **Interview with Dean Scott**

ean Wendy Scott has big goals for Mississippi College School of Law. Since taking over for predecessor Jim Rosenblatt in August of this year, Scott has developed specific aspirations for the law school. In an interview with JYL, Scott was kind enough to share her thoughts.

Noting that the law school has an advantageous location in the heart of downtown Jackson, Scott first hopes to improve the clinical offerings available to students. While emphasizing that nothing can quite duplicate the practice of law with experienced lawyers, Scott believes the law school can do more to make students more practice-ready upon graduation. In the same vein, Scott sees the need for additional courses in business or law office management as more graduates go into business for themselves. These changes, Scott notes, are consistent with the realities of lawyers graduating in this market.

Still, not all of Scott's goals involve experiential learning. She also hopes to grow the academic breadth of course offerings at the school. This can be accomplished in part, Scott says, by growing the faculty as the market allows. By doing this, Scott hopes to see some fresh courses in the future. In fact, Scott may herself teach in one of her personal areas of expertise, Women in the Law.

Undoubtedly, Scott's background makes her an able candidate to achieve these goals, and more. Upon graduating from New York University School of Law, Scott entered law practice. While she spent some time in private practice, she devoted nine years to public interest law in New York City. Thereafter, she entered the academic world, teaching for seventeen years at Tulane Law School and serving as Vice Dean for Academic Affairs. Sadly, Dean Scott, her husband Eddie, and son Christian lost their home to Hurricane Katrina in 2005. As a result, Scott moved to North Carolina Central University School of Law, where she taught and served as Associate Dean through 2014.

It was in North Carolina that Dean Scott became aware that there was an opening for Dean at



Mississippi College School of Law. Scott was impressed by the commitment of the faculty and the energy of the students at MC, and was thrilled to accept the position as Dean. With their help, Scott hopes to grow the law school to provide the best possible educational experience to each and every student.

## **Membership Meetings**

The Jackson Young Lawyers Speakers Committee is excited to present a Fall Speaker Series featuring "Agents of Change in Mississippi." This series is inspiring our membership to learn more about the important issues facing our State and to be engaged in our community in meaningful ways.

### September Membership Meeting: Rachel Cantor



Following an unexpected power outage in downtown Jackson, our first speaker graciously agreed to speak at a rescheduled lunch meeting on September 26. Rachel Canter,

Executive Director of Mississippi First (<u>http://www.mississippifirst.org/</u>) presented, and she was joined by the organization's Deputy Director of Policy, Angela Bass. Mississippi First is a non-partisan, non-profit organization specializing in education policy research and advocacy. In 2013, Mississippi First was named Game Changer of the Year for the Policy Innovators in Education Network for their work. In 2014, Rachel and her co-founder, Sanford Johnson, were named finalists for the Peter Jennings Award for Civic Leadership, an award honoring Teach For America alumni who make transformational change.

- Mississippi First has passed two pieces of watershed education legislation – the Early Learning Collaborative Act of 2013, which established statefunded preK, and the Charter Schools Act of 2013, which allows charter schools to open. Mississippi First remains involved with implementation of these laws.
- Mississippi First also helped the school districts with the highest teen birth rates in the State to adopt evidence-based sex education programs.

- Rachel spoke with our group primarily about Common Core, debunking misconceptions and myths about the program. Mississippi First supports Common Core as the best method for promoting excellence in education in our State. While the program set benchmarks for grade-specific accomplishments, it gives schools the freedom to choose curriculum that works for each school. - Finally, Rachel called on our membership to assist with several projects, including advice about the group's tax exempt status, and research related to the Vegara v. California decision. These projects are excellent pro bono opportunities for our membership. 

### October Membership Meeting: Governor William F. Winter

We were honored to have William F. Winter, Mississippi's 58th governor, speak with our membership at the October meeting. William Winter was and continues to be an agent of change in Mississippi, particularly with education reform and race reconciliation. During his governorship, the Mississippi Education Reform Act of 1982 ushered in mandatory statewide public kindergarten and compulsory school attendance, raised standards for teacher and student performance, and created a lay board of education. His administration also successfully rewrote the state public utilities law when the legislature passed the Public Utilities Reform Act. In 1998, Governor Winter received the Mississippi Bar's Lifetime Achievement Award. Winter was a member of President Clinton's National Advisory Board on Race in 1997-1998. He helped organize the William Winter Institute for Racial Reconciliation at UM in 1999 and in 2008 received the Profile in Courage Award from the John F. Kennedy Presidential Library in Boston. Governor Winter currently serves as special counsel with the Jones Walker law firm. He is married to the former Elise Varner, and they have three daughters, five grandchildren, and two great grandchildren.

As always, Governor Winter was inspiring, earnest, and humorous. With his knack for



storytelling, he related valuable lessons.

• Governor Winter attended the University of Mississippi for undergraduate and law school, and he was elected to the Mississippi House of Representatives while still in law school. Mississippi was the last state to adopt a Worker's Compensation law in 1948, and Governor Winter worked with his colleagues in the House to help ensure passage of the bill. He joked that when he returned to law school the next semester, he had to take a course in Mississippi worker's compensation law!

- Sometimes the smallest efforts make the biggest impact, on the recipient and the benefactor. During his final year in the Governor's office, Winter helped State Line, a small town in Mississippi, secure a much-needed well for clean water. He graciously agreed to fly down to "christen" the new water well, which he admitted was a new one for him! Taking the State helicopter south from Jackson, with railroad tracks as their best navigator, the Governor finally arrived at the water well ceremony and executed his official duties. The town Mayor mentioned that he had never been on a helicopter, and, of course, Governor Winter graciously agreed to take the Mayor up above his town. As they hovered above the crowd and the new water well, the Mayor commented that it was "the highest up he had ever been." Taking the moment in for all that it meant, the Governor commented that he "knew exactly what he meant."
- Finally, Governor Winter called on JYL membership to be leaders, pushing aside partisan politics and working toward results in our State. Expressing characteristic positivity, the Governor remarked that we will be a part of great progress in Mississippi's future.
