# Why Women in the Legal Industry are Paid Enough Already



here are many in what I like to call *Big Media* (I coined that) who talk a lot these days about a gender wage gap. For instance, Big Media recently released a study that found women in the United States earn 79 cents to every dollar earned by men. Statistics in the legal industry are similar and in some studies worse. So what are we to do about this? Nothing, and here's why: because women are Paid Enough Already.<sup>1</sup>

**First things first:** It is not easy being a male lawyer. Male lawyers have significant duties that female lawyers simply cannot perform. Here are but a few examples:

• We have to go play golf with clients regularly. Women don't want or have to do this, particularly because they are not as good of golfers, and because they stupidly don't enjoy talking about Tiger Woods' illegal drop in the 2013 Masters. Sure, we take off Thursday evenings after 4:00 p.m. to hit the camp and sip on Four Roses bourbon while you are writing our briefs through the weekend, but can you think of a better way to build camaraderie among colleagues and business clients? Didn't think so.

Think of it this way too – women being paid less for ostensibly the same work is better for the client. Women are paid less and therefore, their hourly billing rates are less. So, when your client wants work done more economically, you have one of the female lawyers in your firm work on it. This is a client focused business. Sure, women can't take the big depositions, and they might have the dreaded "twelve week vacation," but most do nearly as good a job as men. Case in point, my friend Lance Stevens says that every time he tries a case against a certain female lawyer at Currie Johnson, she just reads the medical records and gets a defense verdict (Honestly, though, where is the talent in that? Low level strategy = low level pay).

Back to a previous point – men do not get to take this nearly annual twelve week vacation. Look, I'd take it in a heartbeat as I have not relaxed in years. But let's face it, these hands aren't made for changing diapers, what with all of the cattle wrangling and firewood-splitting I do on the weekends. Best leave that to the gentle hands of a sweet little missy.
